Before the advent of Islam, betraval was at the forefront of all moral evils, which was leading to all sorts of evils in the society such as, theft, robbery, looting, murder and betrayal of trust, etc. When the light of Islam spread, people were shown the right and wrong path for spending lives and explained the dangers of betraval too. People were advised that they follow Islamic teaching to save their lives from evils. What is Betraval? Betraval means to deceive or defraud someone. According to 3.1. Islam, betrayal is a great crime with humanity. Betrayal includes all evils such as lying, dishonesty, deception, and fraud. We must first understand the meaning of betraval. It comes in treason and dishonesty if one's will not take care of the right of another person. Generally, people consider betrayal to be deceived, but in reality, there are many immoral things involved in it, such as if someone's secret telling to someone else, or someone's trustbreaking. Show off is also betraval. In the same way, if a person does not fulfill the task entrusted to him honestly, it is also a great betrayal. Theft is also a betrayal. This includes evils such as lying, stealing, deception, and fraud. Betrayal is the worst sin that has been called a sign of hypocrisy- Hazrat Muhammad (PBUH) states that there are three signs of a hypocrite when he speaks he lies when he promises he breaks his promise when he is entrusted he betrays.⁶ That is, these are the works of hypocrites, which Muslims should avoid.⁷ The Holy Qurăn says; "do not betray Allah and the Messenger or betray your trusts while you know [the consequence]". ⁸Usually, the concept of betrayal is considered to be special with financial trust. If a person keeps the property in the base of trust and then refuses to return it, it is said that he betrayed. This is also betrayal, but the Shari'ah concept of betrayal is very wide. It is stated in the Holy Qur $\bar{\alpha}$ n that; "That is so al-'Azeez will know that I did not betray him in [his] absence and that Allah does not guide the plan of betrayers". ⁹Hakeem-ul-ummah Mufti ahmad yar khan (may Allah have mercy on him) writes: Betrayal is not only the truth is beyond that, he has betrayed him".¹⁰ The Holy Prophet (PBUH) says that "Whoever advises his brother in a matter while he knows that the truth is beyond that, he has betrayed him".¹¹ At once place Hazrat Maqil bin Yasar said to people that "the Prophet (PBUH) said: "Whoever is made the ruler upon the people and he betrays his rights, Allah Almighty will not enter him in Paradise".¹² The sins of ears, eves, tongue or limbs come in betraval too. This verse is mentioned in Sur $\bar{\alpha}$ h Ghafir that "He knows that which deceives the eyes and what the breasts conceal".¹³ In short, that betrayal is a very great sin, therefore everyone should save himself from this sin. Because each one knows that this world is temporary and the worldly life will be finished very soon, we should think about the second world (Hereafter), and we should follow Islamic teachings to maintain a balanced environment in society.

3.2. Betrayal and Dark Ages: If we talk about pre-Islam, the sin had been spread everywhere. The favorite hobbies of the Arab ignorant were theft, robbery, murder, looting, chaos, kidnapping, sale of alcohol, adultery, and cruelty. The darkness of ignorance was all around. No one was aware of justice, equality, compassion, brotherhood and assistance to the oppressed. Betrayal was common and society was affected from it. Betrayal was not

considered an evil or a sin. In fact, everything was affected from betrayed. Due to which the society was in a state of decline and the man of that time was morally degraded. When the sun of Islam was risen then the lesson of molarity were taught to ignorant man nd and attempt was made to bring him on the right path.¹⁴

Betraval and Islamic Teachings: Islam is a perfect religion and eternal code of 3.3. life. Honesty is a part of faith. A person who believes in Allah and the Hereafter cannot betray anyone's trust. He realizes that Allah Almighty is watching, if I would infringe upon the rights of others or reduce their payments. He will surely be accountable to Allah Almighty on that day when every person will be rewarded for his good deeds. His good deeds will be distributed to others in return for the loss of rights. Then who will have mercy upon his condition there? Such ideas make the believers tremble and then they refrain from betrayal or loss of rights of others. It is advised to human that "then let him who is made trustworthy pay his trust, and let him fear Allah, his Lord".¹⁵ In this verse, Allah Almighty has linked fidelity with piety, ie, one who believes in the afterlife, reckoning and divine judgment, and who has fear of Allah Almighty, should not betray the trust. Because betrayal leads a person to destruction and for such a person there is destruction and ruin in both this world and the hereafter. At an occasion it is stated that "The Prophet (PBUH) predicted that as the Hour of Judgment draws near, the power of faith will diminish, and as a result, honesty will eradicate, and there will be a large population of Muslims, but one and half of the population will hardly be honest and they will not be really honest. People will say, that there is a trustworthy person in that nation. However, he will not be honest and trusty person".¹⁶ When a person says something and leaves, his said words are also the trust. In which there is no room for betrayal. The Holy Qur $\bar{\alpha}$ n says that "O you who have believed, do not betray Allah and the Messenger or betray your trusts while you know [the consequence]".¹⁷ Here an event is explained that "The betrayer will be punished with punishment because the first opinion of Hazrat Umar (RA) was that the perpetrator of the betrayal should be killed but the Holy Prophet(PBUH) forbade him and this is proved by an event that, Hatib Bin Abi Baltah (RA) wrote a letter to the polytheists of Makkah about the secret ideas of Hazrat Muhammad (PBUH). When the Prophet (PBUH) came to know about it, he called him and inquired about it. He accepted his mistake. Then Hazrat Umer (RA) said that let me allow to kill him. The Prophet (PBUH) said: Is he not one of the people of Badr?".¹⁸ Hazrat Muhammad (PBUH) says that "There are three signs of a hypocrite. When he speaks, he lies, when he promises, he does not fulfill, and when he is made a trustee, he betrays".¹⁹ Betrayal is a sign of hypocrites and Muslim is that who try to save himself from this sin. Betrayal is a very bad thing so the Holy Prophet (PBUH) used to seek refuge from it. Therefore, according to a tradition, "The Holy Prophet always prayed for protection from treachery to Allah Almighty, because it is a big torment".²⁰ And I seek refuge in Allah, from treachery, for it is the torment of mischief".²¹ Betraval is the enemy of peace, security, justice, tolerance, equality and brotherhood. Betrayal gives rise to many evils and moral decay in society, so we should follow Islamic teachings to protect society from the scourge of betrayal.

3.4. The Effects of Betrayal on Present Society: Betrayal is a thing from which hardly any aspect of life has survived but due to lack of religious knowledge, we are not aware of it. In present society we can see betraval everywhere i.e, in the business world, telling goods superior, selling dead animal meat, selling counterfeit medicines, sweetening fruits by injecting, refreshing stale food in hotels, misusing the vehicle, electricity, computer, AC, and other things of the company, not giving the right to the rightful, etc. Hundreds of such examples are in present society. Integrity is one of the values that play an important role in cleansing any society from oppression and tyranny, in creating an atmosphere of mutual trust and confidence, justice, and peace.
