It was quantitative study, while the nature of the study was descriptive and survey was used for data collection. The population of the study was all female students who enrolled in section 2018 in all universities in Islamabad and Rawalpindi, where distance education programs exist. Therefore, 260 students were randomly selected. Researcher personally visited and collected the data. Data were analyzed by the help of SPSS (version, 20), percentage, frequency, and mean score was used for data analysis. Data were tabulated in the form of figures and tables.

Because of elastic scheme Allama Iqbal Open University is playing very vigorous part in women growth as well as the national advancement additionally by indorsing female admission to education as well as reducing sex difference. Allama Iqbal Open University Vice Chancellor Dr. Nazir Sangi accurately claims that; as a distance mode of Education University, we inspire women to take admission in a large numbers of educational programs, which offer by Allama Iqbal Open University. Numerous programs were made for women. So, in large number female students were enrolled in these programs in each and every programs. Allama Iqbal Open University is constantly planning to improve its competence to empower women.
